"The 2027 Big Easy Cruise Giveaway"

- 2. **Entry Period:** "The Big Easy Cruise Giveaway" (the "Giveaway") commences at 09:00:01 AM Eastern Standard Time ("EST") on October 3, 2027 and ends at 11:59:59 PM (EST) on October 1, 2026 (the "Giveaway Period"). All entries must be received by 11:59:59 PM (EST) on October 1, 2026.
- 3. **Eligibility:** This Giveaway is open to legal residents of the contiguous United States and District of Columbia, EXCLUDING RHODE ISLAND AND ALL OFF-SHORE U.S. TERRITORIES AND POSSESSIONS SUCH AS PUERTO RICO. Entrants must be at least twenty-one (21) years of age or older at time of entry and be in possession of a valid passport expiring no earlier than July 23, 2027. - 4. **Giveaway Overview:** This Giveaway is one Giveaway wherein one (1) Grand Prize Winner (as defined herein) will be randomly selected by Sponsor following the Giveaway Period. Entrants must also electronically acknowledge and agree to the terms of Sponsor's Privacy Policy and Terms of Use and submit the online entry form as instructed (the "Online Entrant(s)"). Limit one (1) entry per Online Entrant per day. If an Online Entrant uses multiple e-mail addresses to submit more than one online entry, only the first online entry will count. In the event of a dispute over who submitted a winning online entry, the authorized subscriber of the e-mail account used to participate in this Giveaway at the actual time of entry, will be deemed to be the Online Entrant. The authorized account subscriber is defined as the natural person who is assigned an e-mail address by an Internet access provider, online service provider or other organization (e.g., business, education, institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. All entries become the property of Sponsor and will not be acknowledged or returned.
